OLD LOG RECTORY


Whitehorse, YT • Diocese of Yukon

Built in 1901, the Old Log Rectory is among the oldest structures standing in Whitehorse, designated for its historical, architectural, cultural, and social value. It has been used continuously as a residence for clergy since its construction. AFC provided a grant to replace the roof and heating system.




SACRED EARTH CAMP

Salal + Cedar Watershed Discipleship Community is a new ministry to help Anglicans live out the Fifth Mark of Mission: *to strive to safeguard the integrity of creation and sustain and renew the life of the earth.* The camp includes outdoor worship, education, advocacy, and activism. Participants share meals, learn about their drinking water supply, support Indigenous people opposing pipelines on their territory, and visit farms and wilderness areas.
